Generation 2 includes the children of George Musick, Sr. "The Pioneer" who are known to have Descration 2 includes the emidren of George Strusteet of his will and not necessarily in had descendants. They are listed in the order they are named in his will and not necessarily in the order of birth. Again, the approximate birth years shown for this generation have not been documerated and are best guesses provided by family researchers. Notes are included for Generation 2 but, with few exceptions, not for subsequent generations

 DANIEL³ MUSICK (GEORGE³) was born Abt. 1717 in Spotsylvania Co., VA, and died Bet. 1769 - Feb 1775 in NC. He married ELIZABETH (UNKNOWN MAIDEN NAME) MUSICK.

George Musick, Sr., to his son Daniel Musick: "Item I give and bequeath to my son Daniel NOTES for Daniel Musick: Musick one hundred acres of Land joining Willm Trustey being a new patent Land." [This does not take into account any land he might have gotten before George Sr. died. Daniel transferred 62 scres to Thomas Wiatt in 1761, and 30 acres to John Chiles in 1763.]

Also from the will of George Musick, Sr.: "I give to my daughter Agnes Lynes 50 acres joying Daniel Musick & the new Patent Land." This indicates that George, Sr., had already given land to Daniel before he, George, made his will in 1754. He gave Daniel land out of his new patent. So we know that Daniel would have been born before 1730.

Virginia in 1740, a Reconstructed Census, shows Daniel Musick, in Amelia Co., above Flat Creek.

6 Feb 1763: This Indenture made the sixth day of February 1763 Between WILLIAM TRUSTY of the Parish of St. George in the County of Spotsylvania & Elizabeth his wife of the one Part & DANIEL MUSICK of the Parish and County of the other Part for 12 pounds current money of Virginia sell to Daniel Musick William Trusty and his wife Elizabeth sell unto the said Daniel Musick one tract of land situated and lying & being in the Parish of St. George in the county of Spots, containing by Estimations Fifty Acres be the same more or less and bounded on the lands of James Sandage, William Thurston, Thomas Wiatt and the said Daniel Musick.

30 July 1763 between Daniel Musick of the County of Spotsylvania Colony of Virginia and Elizabeth his wife of the one part and John Chiles of the County and Colony aforesaid, sold a parcel of land containing 30 acres lying in the county of Spotsylvania on the East side of the
