6. ELIZABETH<sup>2</sup> MUSICK (*GEORGE*<sup>1</sup>) was born Abt. 1723 in St. George's Parish, Spotsylvania Co., VA. She married WILLIAM TRUSTY 1746 in Spotsylvania Co., VA.

NOTES for Elizabeth Musick and her husband William Trusty:

1743 - February 7: Feb 7, 1743 - 250 - On the motion of WILLIAM TRUSTY and ELIZABETH his wife they are allowed for five days attendance each as evidence of a summoned by George Musick - it is ordered that George Musick pay them 250 pounds of tobacco for same.

1746 - June 3: Elizabeth (Musick) Trusty and her husband William Trust were deeded 50 acres by her father, which may have been a wedding present, June 3, 1746 [if the above 1743 date and the 1746 date in this record are correct, this 50 acres would not have been a wedding gift unless there was a delay in having it officially recorded] in St. George's Parish, Spotsylvania County, Virginia.

August 1, 1764 William Trusty sold 50 acres to Daniel Musick.

1746 - June 3: GEORGE MUSICK, Senr. and ANN, his wife, of St. Geo. Parish, Spotsylvania Co., William Sandige (Sandrige) and Ann, his wife, of same parish and county to William Trustee of same parish and county 'sd. George Musick, Sr. and Ann, his wife, to William Trustee, their son-in-law, and Elizabeth, his wife, their daughter.' Deed of Gift, 50 acres, and sd. William Sandidge and Ann his wife, for consideration of \$4 curr., to them by sd. William Trustee paid, convey 15 acres adjoining the afsd. 50 acres. Witnesses, Thomas White, William Lea, Phillip Ballard. June 3, 1746. (Believed to be at the time of their marriage.) [If the Feb. 7, 1743 date cited at the beginning of these records is correct, the couple were already married in 1743.]

1758 - July: William & John Trusty were on a list of voters for an election.

1763 - February 6: William Trusty of St. George's Parish, Spotsylvania Co., VA and Elizabeth, his wife, to Daniel Musick of parish and county aforesaid 12 (lbs) curr., 50 acres in St. George's Parish, Spts. Co. Witnesses, HENRY CHILES, JOHN CHILES, JOSEPH VENABLE, Aug. 1, 1783

✓ 1778: Colonia Papers of NC - William Trusty took oath of allegiance in Nap of Reed District of N.C. in 1778. The researcher for this states that this is in Granville County, North Carolina. There is no record of a Trusty ever owning land in Granville County. It was a militia district in
